Building Mutual Success at ATCO

Since 1987, Two Rivers has been creating Aboriginal partnerships throughout Canada and Alaska. These partnerships have developed profitable businesses and longterm relationships based on a foundation of trust, respect and equality.

We work in a joint-venture partnership with the Fort McKay First Nation in Alberta's oil sands. Our organizations own and operate Creeburn Lake Lodge and Barge Landing Lodge, open accommodations for more than 2,500 oil sands workers located north of Fort McMurray. In 2008 this joint venture grossed over \$6 million in commercial revenue for local contracting companies.

In the North, we work with the Pan Arctic Inuit Logistics Corporation through the Nasittuqá joint venture to operate Canada's North Warning System. This initiative continues to deliver capacity building and long-term sustainability.

Creating Opportunities and Leaving Legacies

Throughout Canada, we have formed partnerships that have started from simple conversations. Before projects are identified or plans are made, our relationships grow from getting to know each other and we maintain a corporate policy of listening first.

Recognizing and celebrating talent in the communities we partner with is significant to our success. Supporting community growth through training and education is important to us. We believe that employing Aboriginal peoples and businesses will benefit all Canadians by empowering Aboriginal communities and generating a muchneeded local labor source for Industry.

In February 2009, ATCO and the Fort McKay First Nation were recognized and honored by the Government of Alberta and the Alberta Chamber of Resources with the Rewarding Partnerships Award for excellence in innovation and best practices in Aboriginal programs.

We are involved with several organizations including the National Aboriginal Achievement Foundation, the Canadian Council for Aboriginal Business and the Community for Aboriginal Relations, and we are also pleased to provide annual scholarships to Aurora College students.



A range of accommodation options

Two Rivercan provide a range of accommodations for your workforce as well as for teams and officials participating in your event. Barge Landing and Creeburn Lake Lodges

Together with the Fort McKay First Nation, our joint venture partnership owns and operates the Creeburn Lake Lodge and Barge Landing Lodge. Located north of Fort McMurray, these accommodations house more than 2,000 oil sands workers and require employees and contractors for a variety of positions, from laundry services to site administration.

The benefits to the First McKay First Nation are enormous. In its first year, Creeburn Lake Lodge alone generated more than \$6 million in commercial revenue for local companies. And as a joint-venture partner, members of the First McKay First Nation are eligible for ATCO's Aboriginal Scholarship Program. The program provides \$1,000 for students demonstrating a commitment to their education, leadership, and community involvement.

Barge Landing Lodge

The 300,000 square-foot Barge Landing Lodge accommodates over 1,500 oil sands workers. Operated by our joint-venture partnership with the Fort McKay First Nation, the lodge provides complete meal services and housekeeping services. Our joint venture also provides maintenance and administration services.

Creeburn Lake Lodge

Constructed in 2008 as a home for resource and construction workers, Creeburn Lake Lodge accommodates up to 600 workers in the Fort McMurray area.

Built and managed as a joint venture between ATCO Structures & Logistics and the Fort McKay First Nation, the lodge first provided employment benefits as a construction project. Now, our joint venture continues to employ a variety of staff in operations, administration, and maintenance.
